## PRIVACY NOTICE FOR THE GAME "EAT, PLAY, AND WIN WITH AEROTTORIA"

### 1. GENERAL PROVISIONS

This privacy notice applies to participants of the game "Eat, Play, and Win with Aerottoria" (hereinafter – the Game) whose personal data may be processed during the Game.

This privacy notice provides information on what personal data is processed, for what purposes and legal basis, how long personal data is stored, what rights data subjects have, and other legally required information.

### 3. WHAT PERSONAL DATA IS PROCESSED AND FOR WHAT PURPOSE?

We process your:

- Name, surname, email address, and phone number provided in the Game participant's form;
- Purchase receipt attached to the Game participant's form;
- Prize handover-acceptance document details (if applicable).

Personal data is processed for the purposes of:

- (i) Administering the Game;
- (ii) Determining the winner and delivering the prize;
- (iii) Defending against claims or complaints related to the Game.

Before handing over the prize, your identity will be verified. If the provided information does not match actual circumstances (e.g., the participant is under 18 years old), the prize will not be awarded.

### 4. LEGAL BASIS FOR PROCESSING PERSONAL DATA

The legal basis for processing personal data for Game administration and execution is your **consent**, expressed by checking the relevant box in the Game participant's form.

Participation in the Game is voluntary; however, to participate, you must provide the required personal data. If you refuse to provide your personal data, participation in the Game will not be possible.

You have the right to withdraw your consent at any time, which will terminate your participation in the Game.

The legal basis for processing personal data for winner determination and prize delivery is the **fulfillment of legal obligations** – the Company's obligation to award the promised prize according to the Game rules.

The legal basis for processing personal data for legal claim defense is the **Company's legitimate interest** in protecting itself from claims or complaints related to the Game.

### 5. PERSONAL DATA STORAGE PERIOD

Personal data is stored for **three (3) months** after the Game ends, according to the Game rules, or until you withdraw your consent. If a complaint or legal dispute arises, personal data will be stored until the dispute is fully resolved.

### 6. DISCLOSURE OF PERSONAL DATA

In accordance with legal requirements, your personal data may be disclosed to state authorities if a request is received or if there is another legitimate basis. Access to your personal data may also be granted to the Company's employees responsible for organizing and executing the Game.

## **7. TRANSFER OF PERSONAL DATA OUTSIDE THE EU/EEA**

Your personal data is processed and stored **within the EU/EEA**. Data is not transferred to third countries or international organizations.

## **8. AUTOMATED DECISION-MAKING OR PROFILING**

We do **not** apply automated decision-making or profiling to your personal data.

## **9. YOUR RIGHTS**

You have the right to:

- Be informed about the processing of your personal data;
- Access your processed personal data;
- Request correction of your personal data;
- Request the deletion of your personal data ("right to be forgotten") in certain cases;
- Request restriction of personal data processing in certain cases;
- Object to the processing of your personal data in certain cases;
- Withdraw your consent at any time;
- Request the transfer of your personal data to another data controller ("data portability") in certain cases.

## **10. WHERE TO FILE A COMPLAINT?**

If you believe that the Company processes your personal data in violation of legal requirements, you have the right to submit a complaint to the **State Data Protection Inspectorate (VDAI)**:
